- (a) Disciplinary action will be initiated in respect of the Members giving false information.
- (b). Splitting of requirements to avoid the charges while utilizing Accommodation for the Marriage Ceremonies are not permitted.
- (c) Incomplete forms will not be accepted.
- (d) Refunds, if any, on cancellation of booking will be made after deductions as per Club Rules.
- (e) Members will ensure compliance of essential conditions given overleaf.
- (f) **"Hooka" smoking is strictly prohibited in club premises.**
- (g) Prior permission to be taken from Secretary for any additional arrangements being brought within the Bareilly Club premises i.e. photographers, musician or any event.
- (h) The Corkage Charges will be 60% in addition to the venue charged.
- (j) For Swimming Pool only: No DJ, outside catering & Bar is permitted.
- (k) Rs., 50/- per head catering surcharge. If catering is outsourced.
- (l) In case the strength of Guest exceeds the max laid down strength. Charges @ Rs. 200/-per head will be levied the venue
- (m) The legal and operational responsibility of placing a fire engine in outside locations mentioned at paras 2(a) to (d) above is that of the booking party and not of Bareilly Club. Any fire incident on the day of the accident in the booking party's venue is their sole & undivided responsibility.

- (a) Noise Pollution. Will comply with Hon'ble Supreme Court Orders i.e. to check noise pollution by Loud Speakers / Band / DJ etc and bursting of Fire Crackers after 10.00 PM during private functions / marriage ceremonies etc. However, low volume Music upto 11.00 PM may be played. **Additional Security deposit @ Rs. 20,000/- will be paid in advance at the time of booking for complying with Supreme Court orders on playing of Loud speaker/Band/DJ music upto 10 PM only. In case of exceeding the above time limit the security amount Rs. 20,000/= will be forfeited as penalty.**
- (b) Compliance of Excise Rules. Will comply with Govt of U.P. Excise Department Order i.e. Liquor from unauthorized sources i.e. from other States and CSD Canteens will not be permitted inside the Club premises, during private functions and will obtain Excise Permit from Distt Excise Officer, if separate Bar is to be established in the party Venue.
- (c) Ban on Domestic Gas Cylinders. Only commercial Gas cylinder will be used during the party by the Caterer.
- (d) Hygiene and Sanitation. Will ensure general cleanliness all around the Party Venue by the Services providers that is, Tentage / Shamiana / Seating etc, the Caterers and Music/DJ organizers. In case of Damage/unfair Wear & Tear to any club property/venue would pay the penalty as deemed fit by the management committee..
- (e) Fire Safety measures. Will ensure all fire safety measures to be undertaken at the cooking area & various Tents being placed. However, Bareilly Club management will not be held responsible for any fire hazard or loss of property & life due to fire.
- (f) Dress code of Bareilly Club to be followed by all members/invitees for entry into Club premises.
